The Registered Designs (Amendment) Regulations, 1981

IN EXERCISE of the powers contained in section fifty-eight of the Registered Designs Act, the following Regulations are hereby made:

1. These Regulations may be cited as the Registered Designs (Amendment) Regulations, 1981, and shall be read as one with the Registered Designs Regulations (hereinafter referred to as the principal Regulations) and shall apply in respect of business conducted after the publication hereof.
